Second Annual Law Rocks Washington DC at the Annual Conference of the International Bar Association Breaks Records

Nonprofit organization that hosts legal professionals in battle of the bands fundraising concerts returns to Washington with their largest concert ever.

Washington DC, September 19, 2016 – Law Rocks, the nonprofit organization that hosts a global series of fundraising concerts starring bands of legal professionals, is presenting the Second Annual Law Rocks Washington DC this Thursday, September 22. The event coincides with the Annual Conference of the International Bar Association at which Law Rocks has presented an event for the last three years. A record fourteen bands representing over 25 law firms will rock out for charity. Held at the acclaimed 9:30 Club, the night has surpassed last year in total fundraising, at just over 100K already.

Competition will be fierce as last year's DC winner, The Fine Print of Shulman Rogers, and last year's IBA Vienna winner, IM Beats of Irwin Mitchell, compete against returning and new bands. The winning band will be selected by four factors: donations raised, tickets and sponsorships, audience favorite, and Rock Panel of Judges score. The Rock Panel includes Grammy award winning singer/songwriter SONiA disappear fear; music industry veteran and Executive in Residence at American University Kogod School of Business, James Simson; engineer at Cue Recording and producer of *The Circus Life* podcast, Sean Russell; Davis Law PLLC founder and Washington Area Lawyers for the Arts board member, Beverly Davis; and music industry veteran and owner of Bialek's Music LTD, Ray Bialek.

"Last year's DC event was amazing," says Law Rocks Director of Marketing and Development, Omi Crawford. "The band were excellent and so enthusiastic. It's a thrill to return with an even bigger night in store." Proceeds from tickets sales at the event will be donated to the International Bar Association Human Rights Institute. The fourteen participating bands are also fundraising to benefit area charities and a representative from each organization will speak at the event. The nonprofits are Bridge of Books Foundation, Calvary Women's Services, Catholic Charities of the Archdiocese of Washington, Central Union Mission, Children's Law Center, Doorways for Women and Families, Epilepsy Society, GoodWeave, HomeAid Northern Virgina, Lex Mundi Pro Bono Foundation, London Air Ambulance, Montgomery County Coalition for the Homeless, MQ, and Together We Bake.

After seeing success from the first concert in London 2009, Law Rocks brought the event to the United States in 2012. "When I started Law Rocks in London seven years ago, I never expected it to become a global organisation," Nick Child, founder of Law Rocks, commented. "The DC IBA event is Law Rocks at its best – legal professionals from all over the globe coming together to help those less fortunate, while putting on quite a show."

As an organization, Law Rocks Global has raised over \$1,500,000 for various nonprofits across the world. The Washington DC concert is followed by stops in London, Singapore, Sydney, Melbourne, New York City, and Dubai as part of the 2016 Law Rocks World Tour.
